### **Permission to leave the school premises**

Instead, we ask for your permission at the start of the year for all such visits.

The following are examples of trips covered by such permission:

- A class trip that walks into Cawston during school hours
- We visit St Agnes Church for Harvest Festival and at Easter during school hours
- A class trip to the Church during school hours

Of course, we will ensure that such trips are suitably supervised by appropriate staff.

Sometimes pupils participate in school trips that involve:

- a significant journey
- an overnight stay
- anything unusual

When this is the case we will provide full details and require parental permission before your son / daughter can participate in the trip.
